Description of Misconduct or Wrong Doing Witnessed: I have learned that **Dan Houston**, current Sheriff of Bernalillo County has announced his candidacy for reelection. This information was made public through his statements on Facebook and is evidenced by his website: sheriffhouston.com. It was further learned through public statements made by Houston and his campaign manager, Darrell Kindig, that they are currently using the Bernalillo County Sheriff's Department Headquarters, located on the 5th floor of the Law Enforcement Center, 400 Roma NW, as Houston's political reelection campaign headquarters. Kindig's name can be regularly found on the publicly available sign in logs for this secured government building, and when asked, has openly admitted that he and Houston are using the Sheriff's headquarters as their campaign office.

This is clearly a violation of the above mentioned sections of the Bernalillo County ordinances and NM State Statutes and as such rise to the level of a 4th Degree felony, in that Houston is knowingly and willfully using public resources for his personal gain. The illegality of this was also pointed out to him by KRQE reporter Katie Kim as being wrong, and Houston freely admitted on television that he was knowingly using this public office space in a public building for his personal gain. It should also be mentioned that Houston is also using the County issued cellphone, and cell service on a regular basis for his personal gain. Since he took office in 01/2011 Houston has not had a personal cell phone and has relied on his government issued phone for his personal use and is now using it for his campaign.

Houston has routinely assigned two Sheriff's Department employees to work on his campaign by taking photos of him while on the clock, with government equipment and then used those photos for purely political purposes. Some of these photos can be seen on Houston's

website mentioned above and others can be seen on his private Facebook page. The two employees currently working on his campaign while on County time are Anthony Segura and Jim Dixon. One of whom is the department webmaster, and the other is the department photographer.
