

Application for Bernalillo County Residential Outdoor Water Use Survey and Rain Barrel Program.

(For residents of unincorporated Bernalillo County who are not Albuquerque Bernalillo County Water Utility Authority (ABCWUA) water customers.)

Participating residents must complete this application and participate in an Outdoor Water Use Survey which will identify outdoor water saving opportunities and determine eligibility for receiving a reduced-price rain barrel from Bernalillo County. The reduced cost of the rain barrel (100 gallon size) is \$40.00
